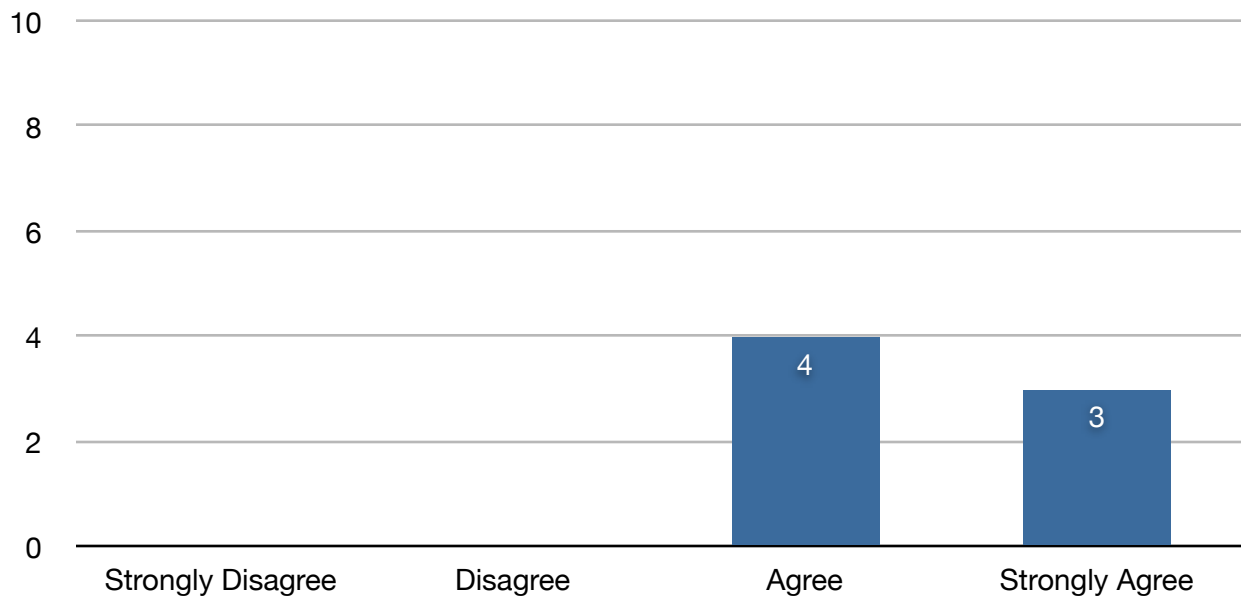

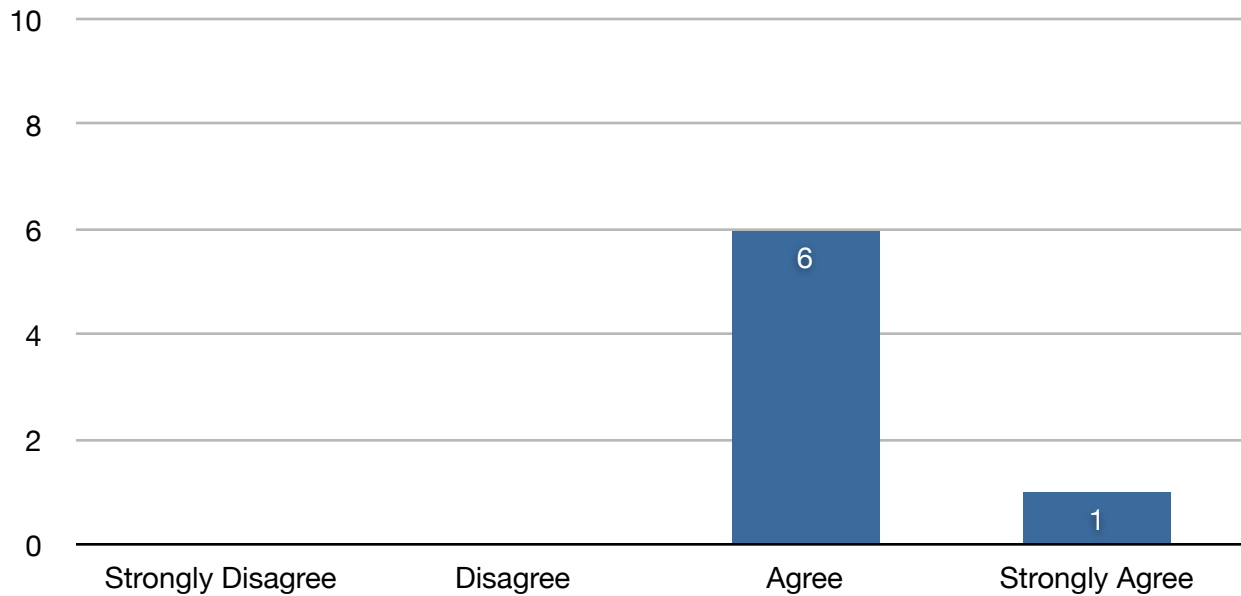

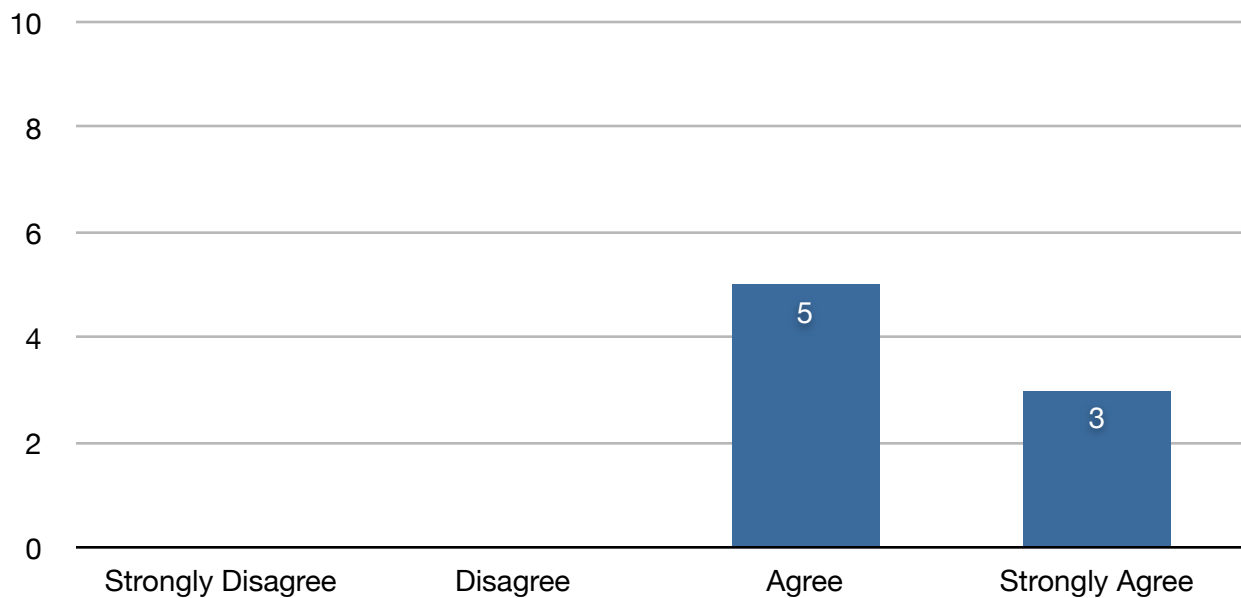
**Q1: I am actively involved in school activities, conferences, and area meetings outside of the scheduled monthly board meetings.**



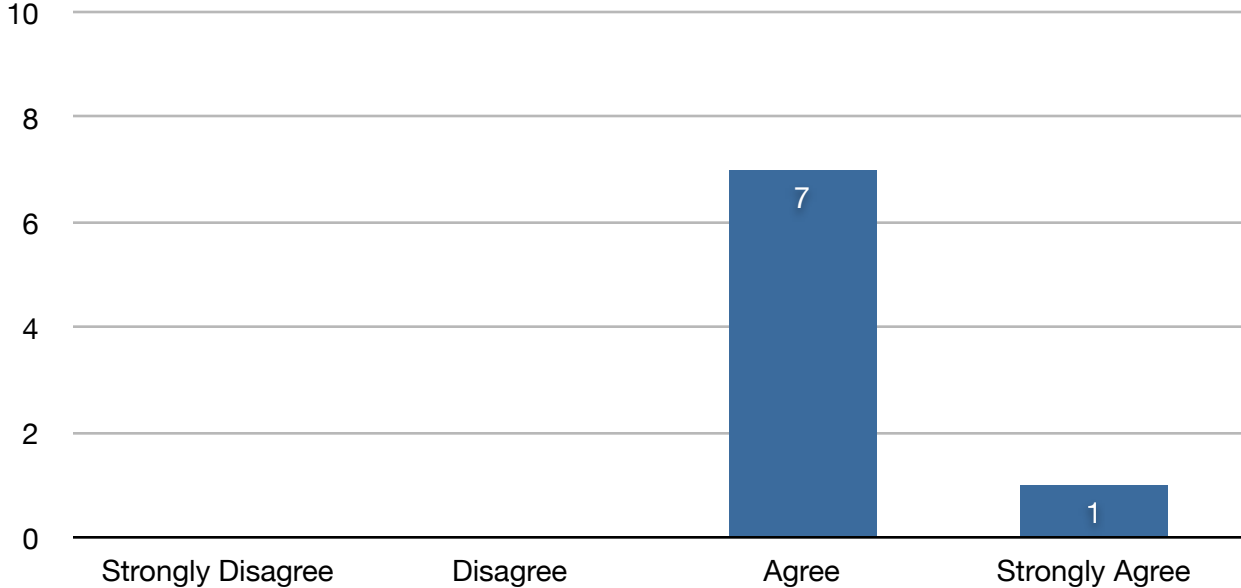
**Q2: Students can see the connection between what they are learning and the rest of their life.**



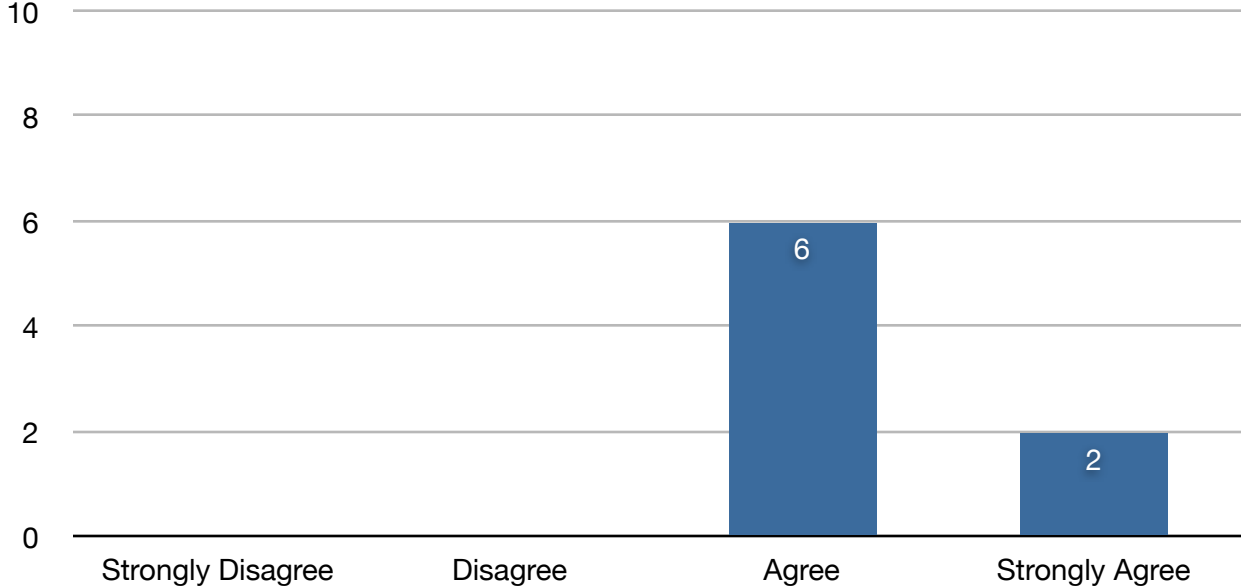
**Q3: Our communities are adjusting adequately to the changes that have come about by the sharing between our four districts.**



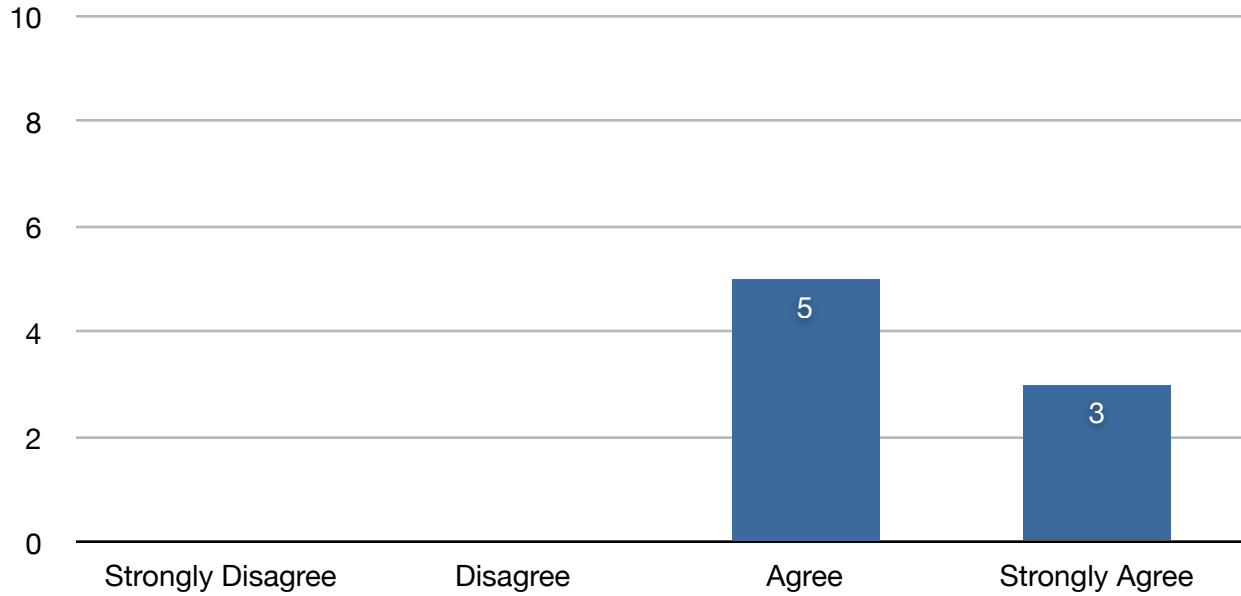
**Q4: We can adequately fund the quality of education we aspire to.**



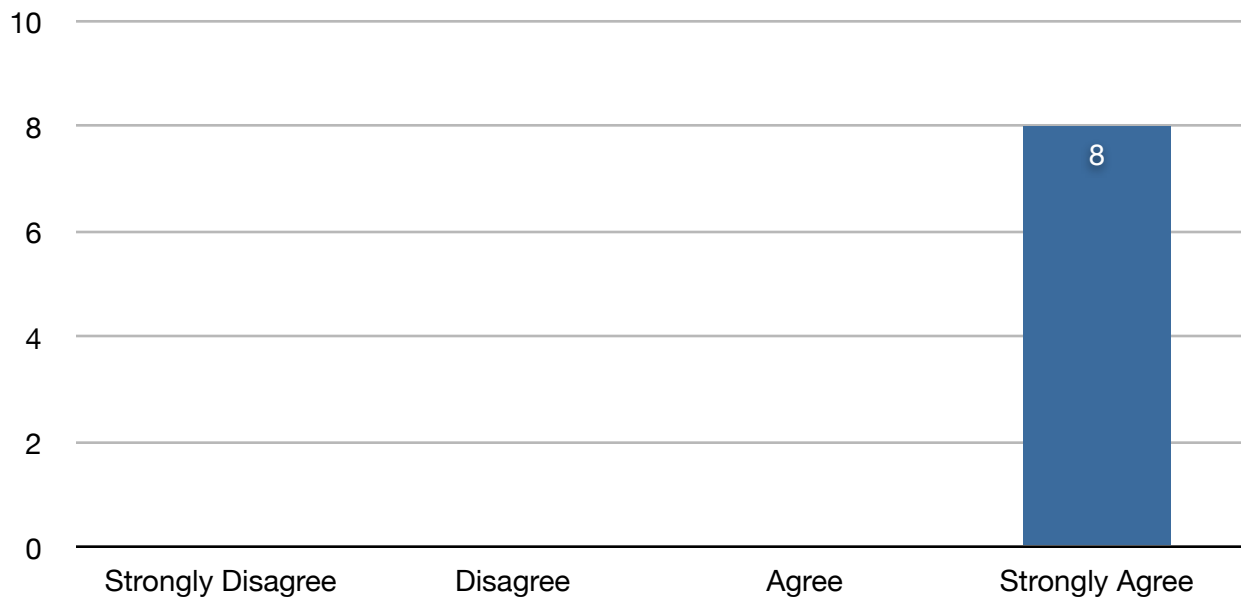
**Q5: We can adequately fund the facilities and infrastructure we need to provide the quality of education needed to succeed in the 21st Century.**



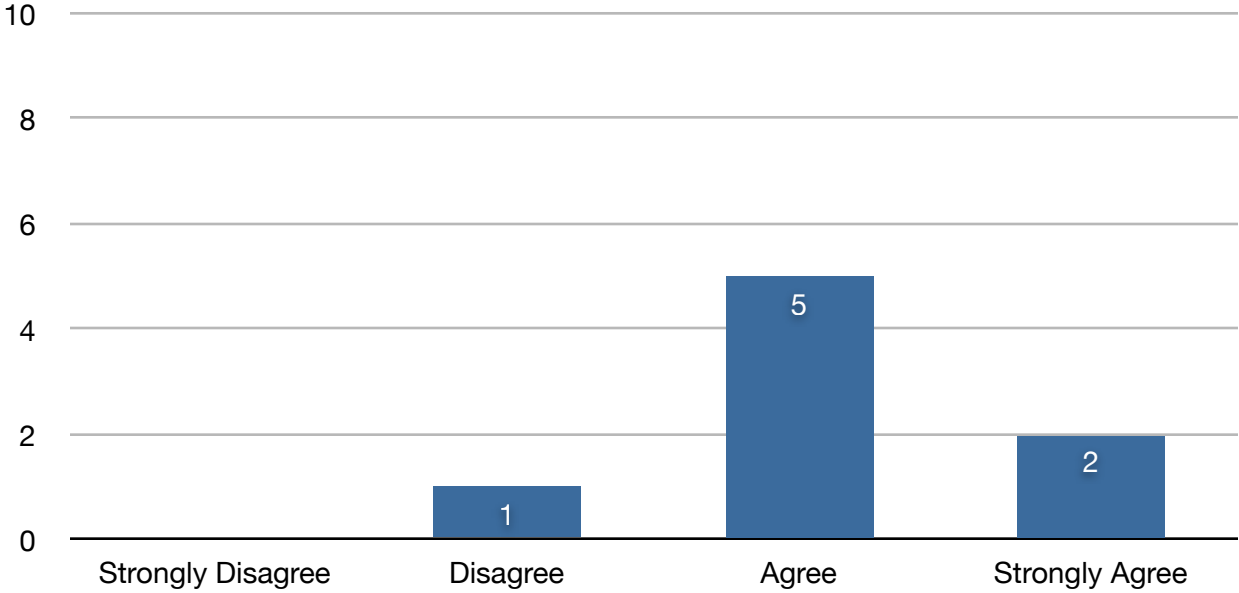
**Q6: The pace of the changes we are making is appropriate given where we need to go.**



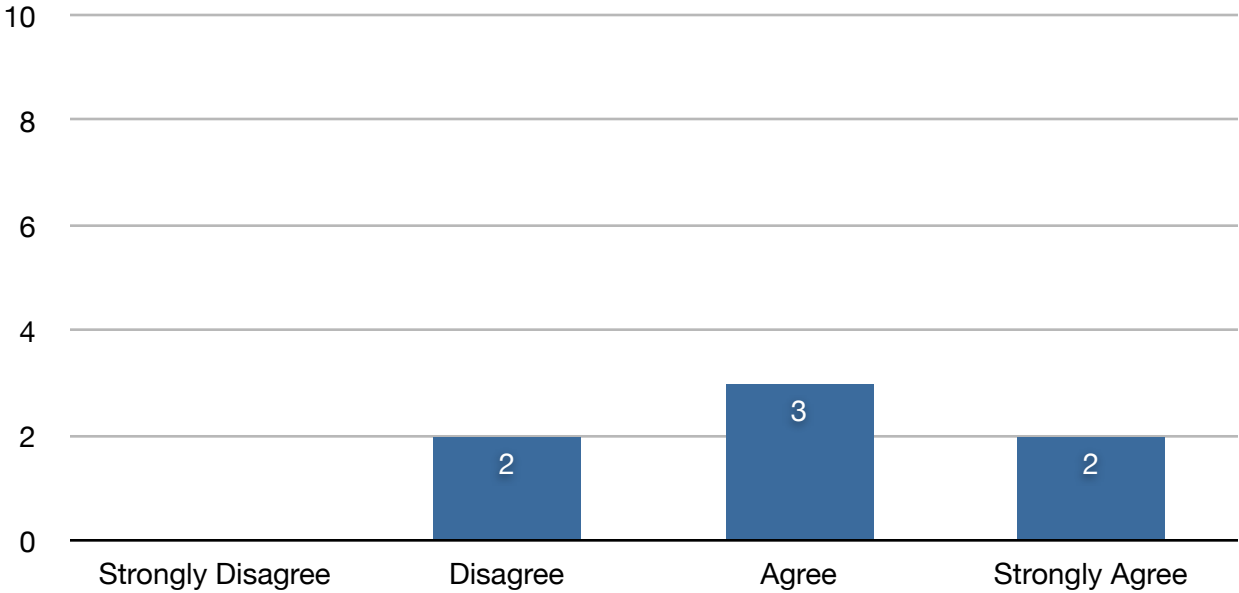
**Q7: I am proud of the community's response to the changes we've been making.**



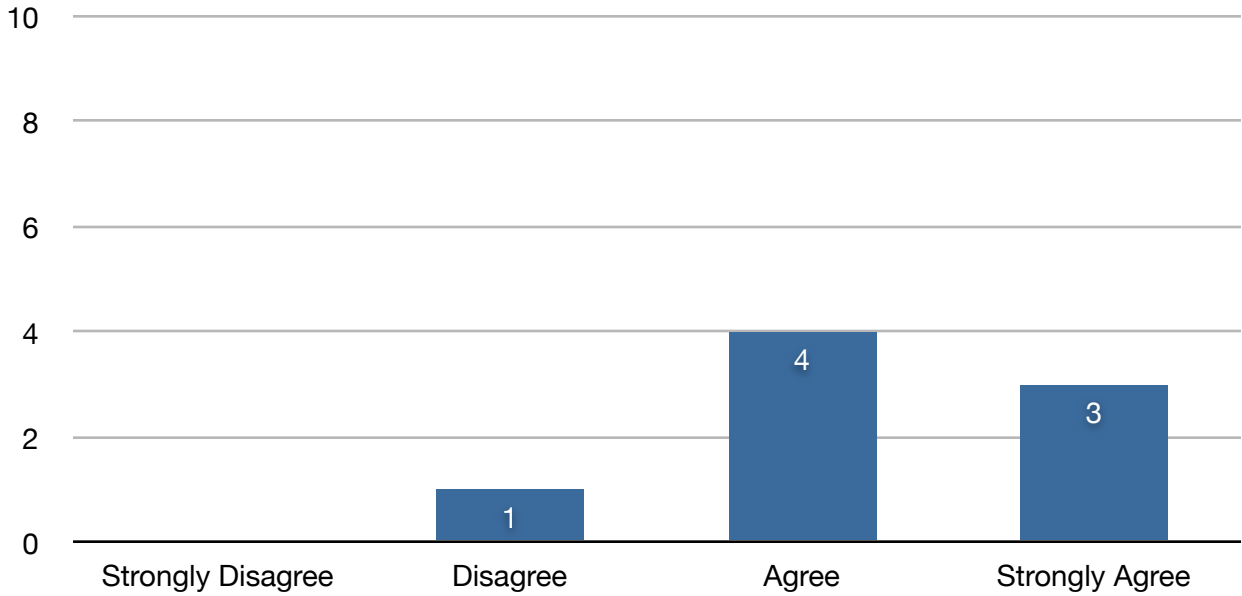
**Q8: Teachers and administrators are open to and consider student and parent concerns and suggestions.**



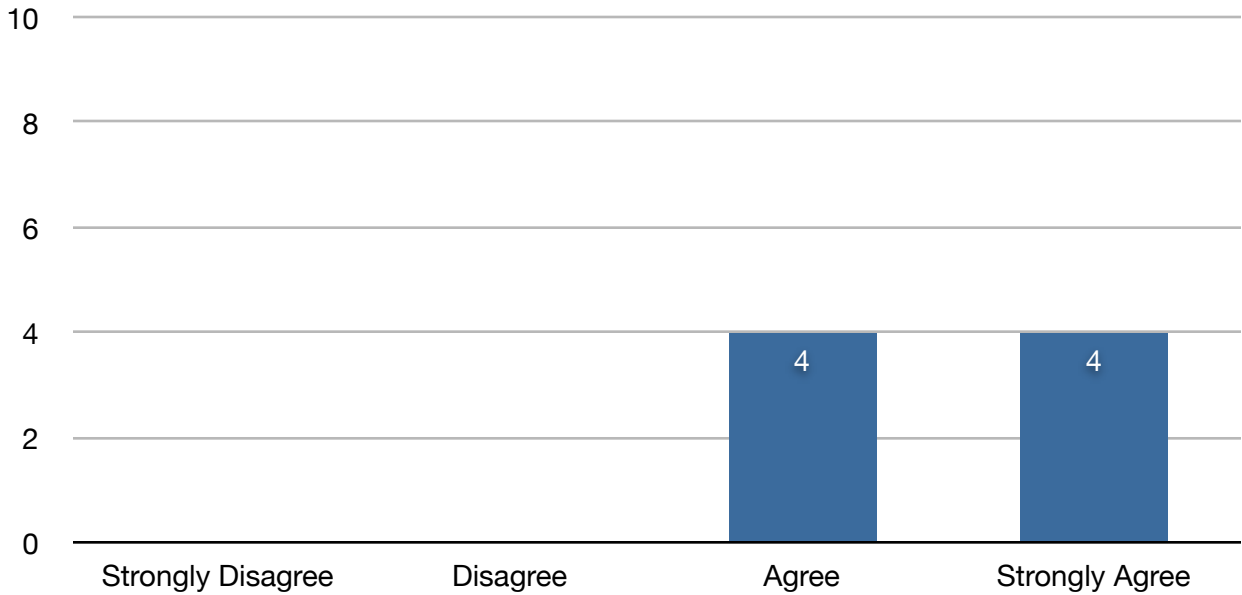
**Q9: Bullying and harassment are effectively addressed in our schools.**



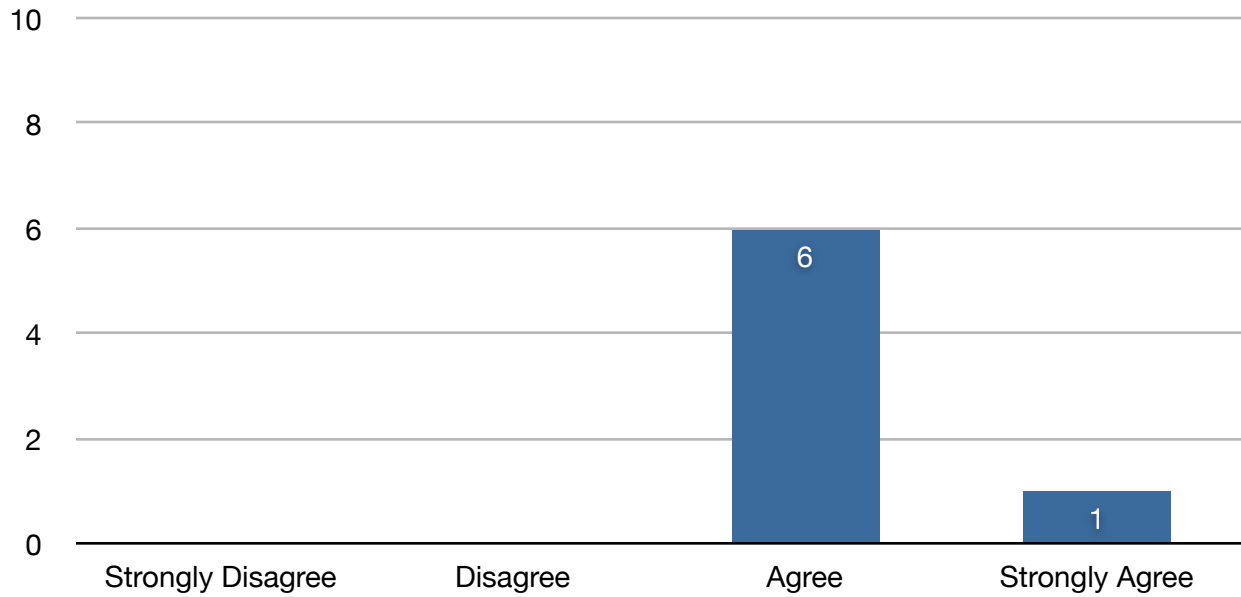
**Q10: School policies and handbook regulations i.e. attendance, cell phones, and class-room rules, etc. are written and enforced in a fair and consistent manner.**



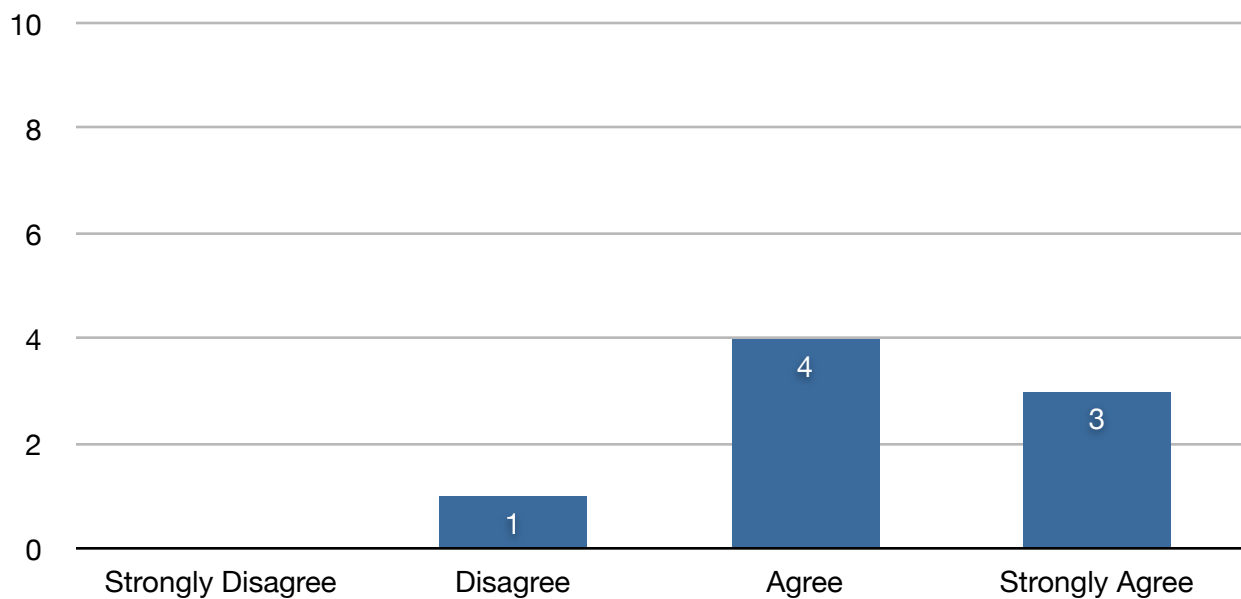
**Q11: Students and parents have adequate access to grades and other school information on our district webpage.**



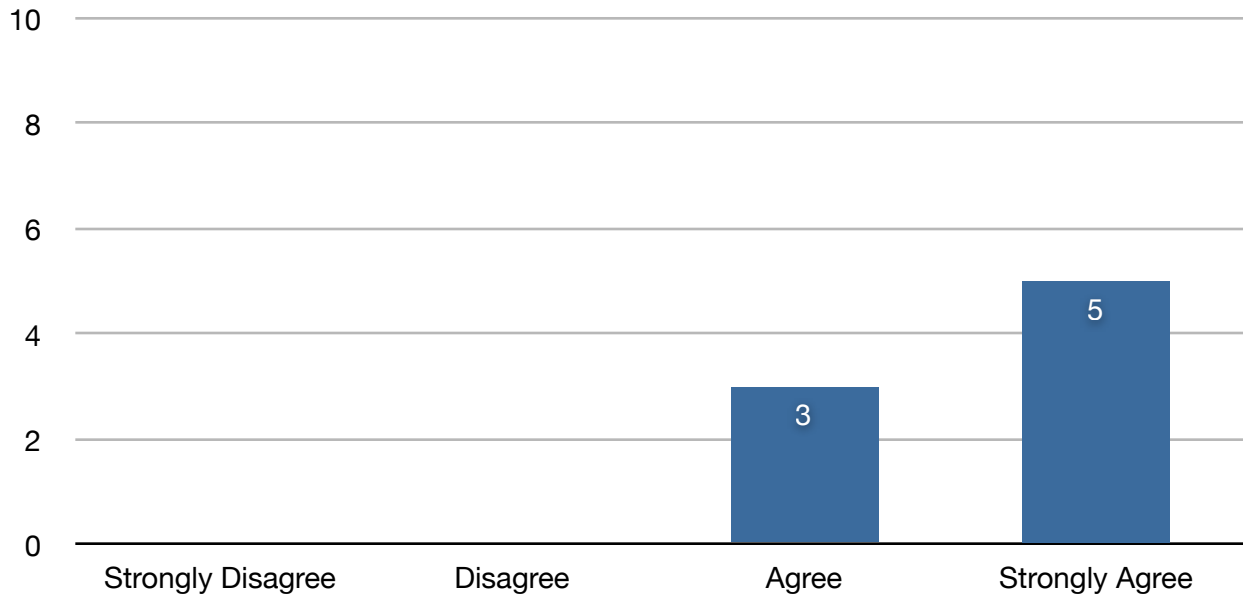
**Q12: The floating study hall and advisor/advisee time increases class enrollment and is necessary for students to complete homework assignments and/or access help from teachers/advisors.**



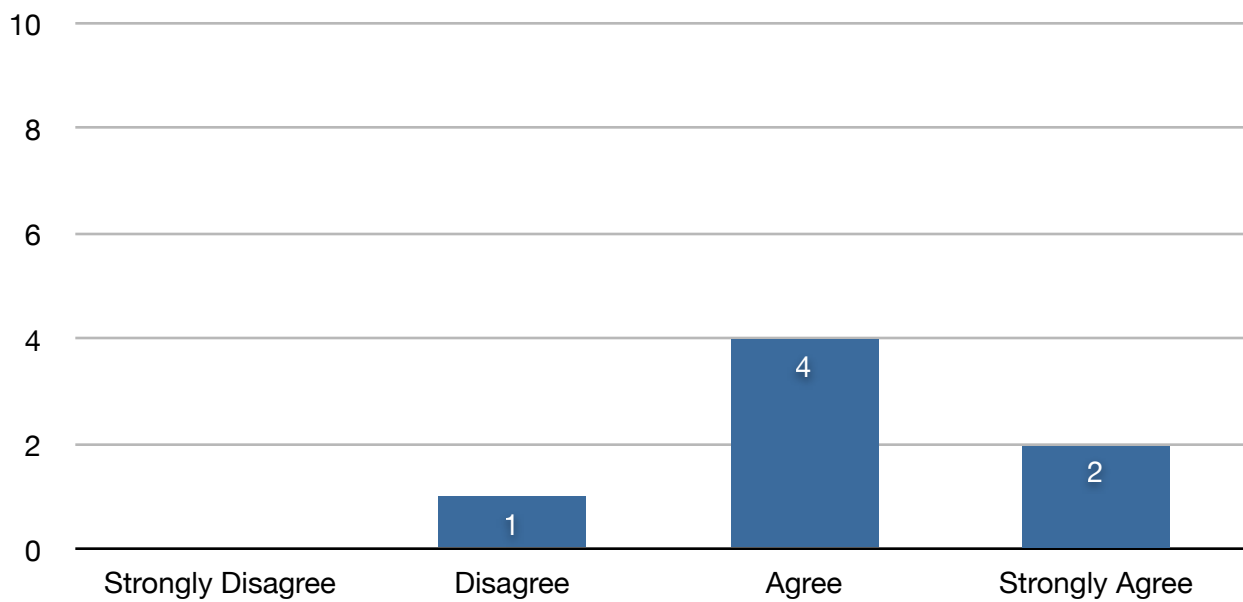
**Q13: Students and parents have access to all teachers, counselors, and principals.**



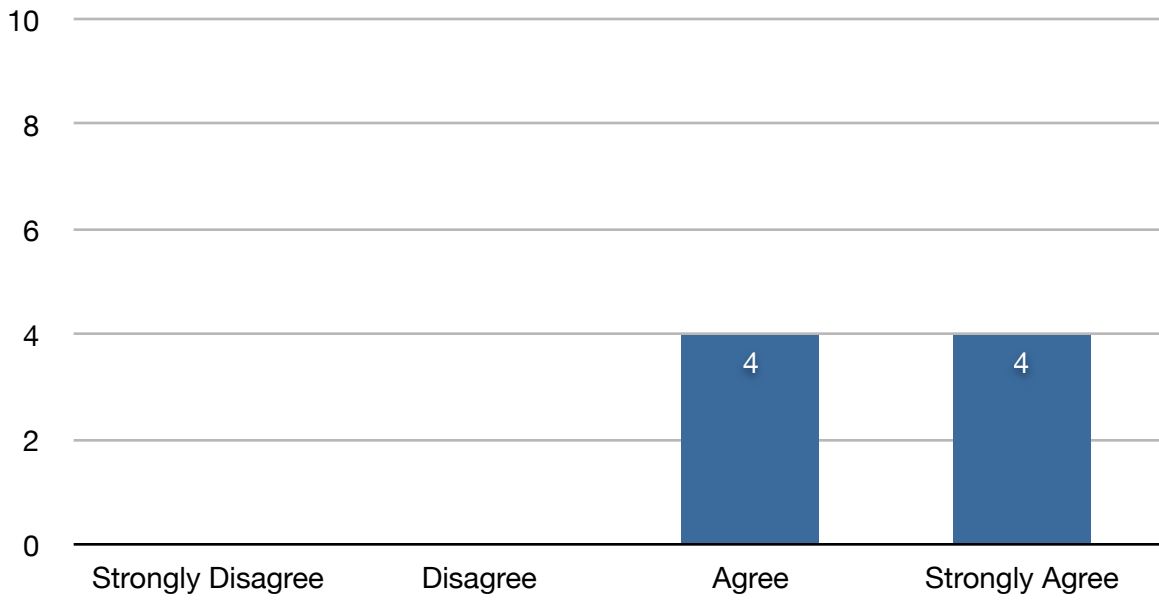
**Q14: The four-school partnership provides educational opportunities and benefits students in both the four-day and five-day schools.**

**Q16: I believe our students' learning in the distance-learning classroom is comparable to his/her learning in the traditional classroom.**



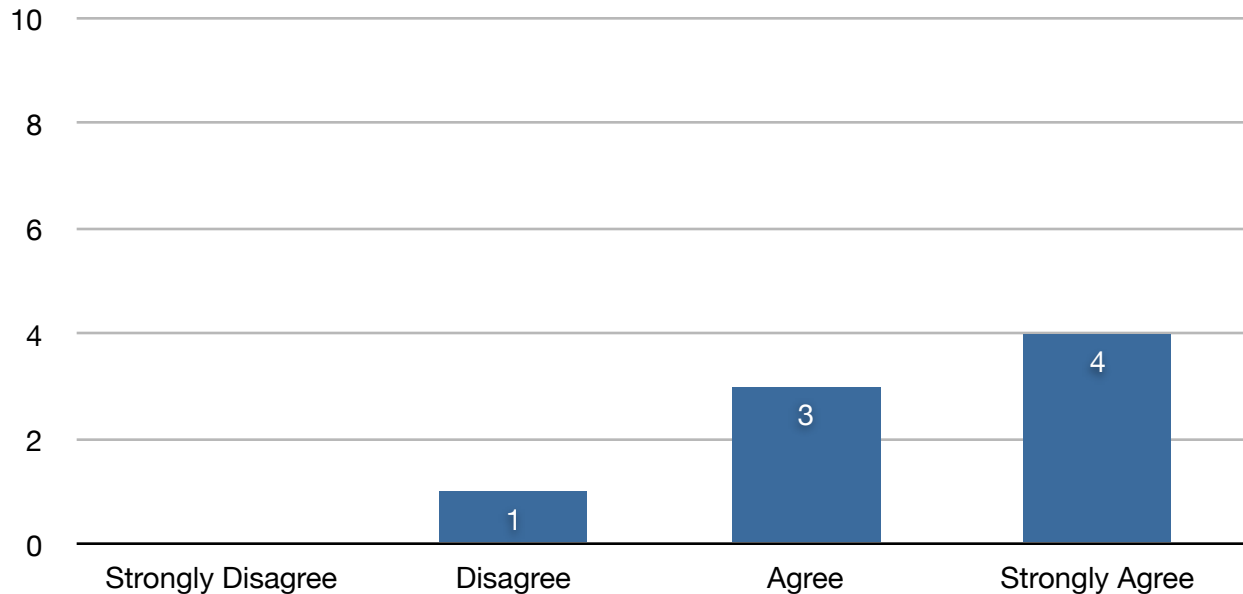

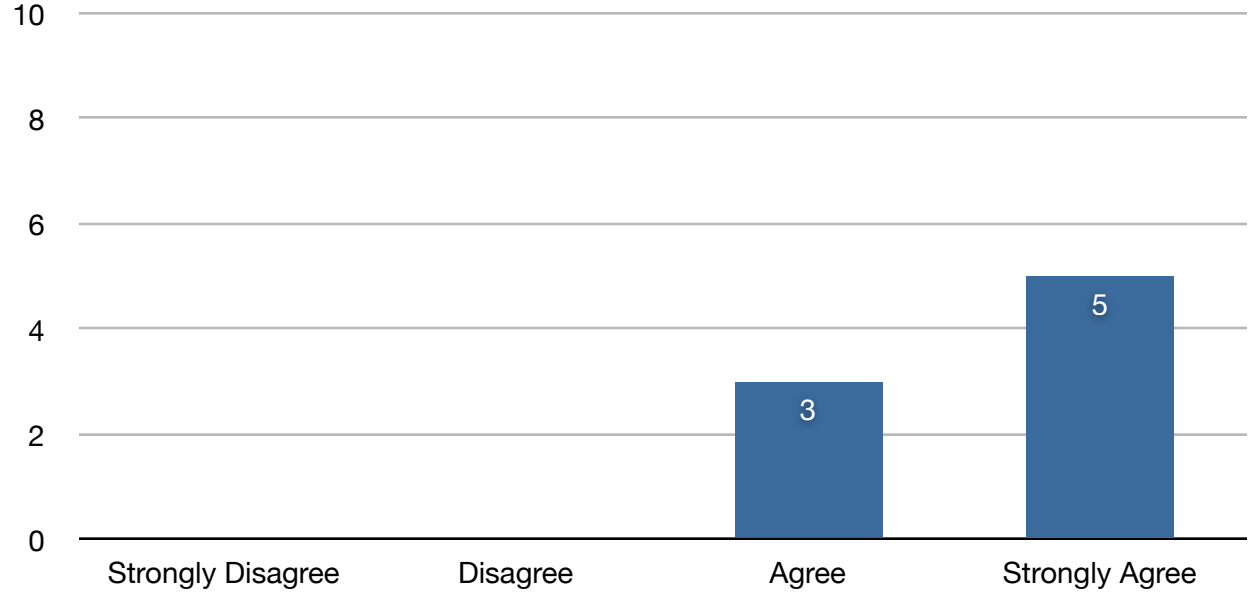

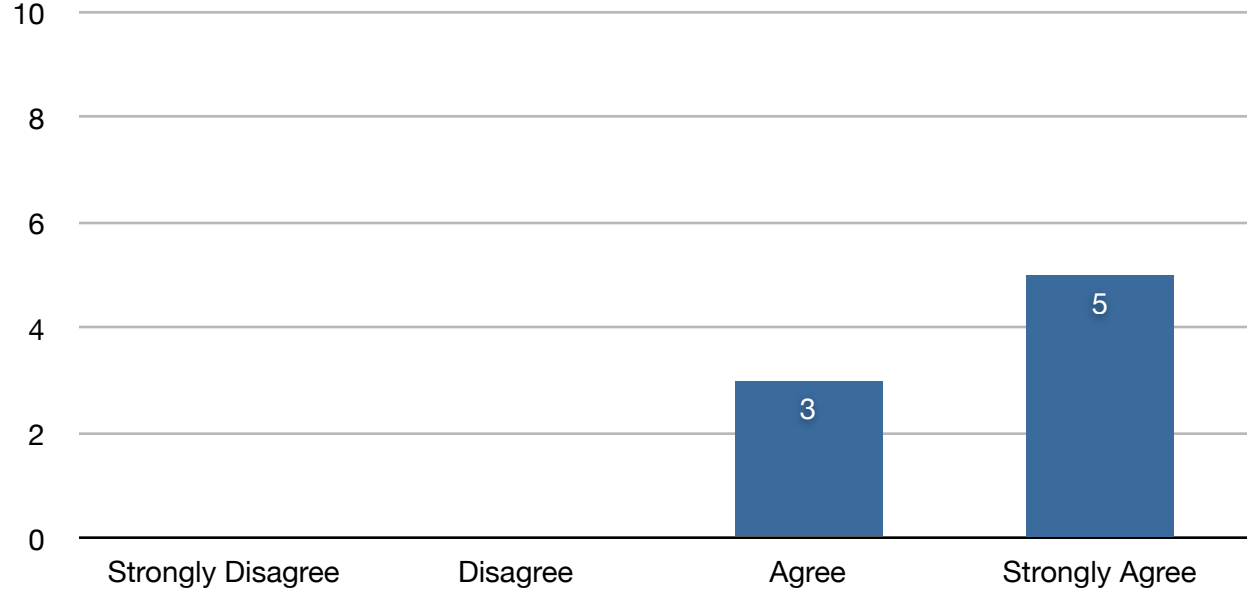
**Q17: Our vision for schools in each of the four communities is more than adequate to provide the right learning environment and opportunities for our youth.**



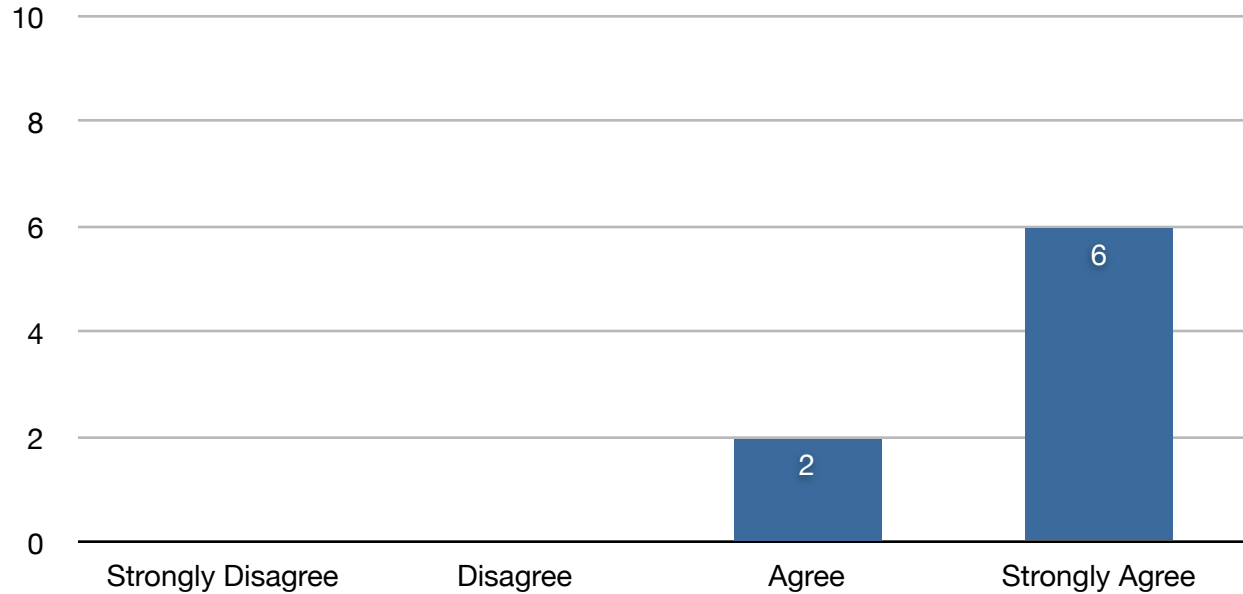
**Q18: We have the leadership required in both board and administration to sustain our schools and provide quality-learning opportunities for our youth.**



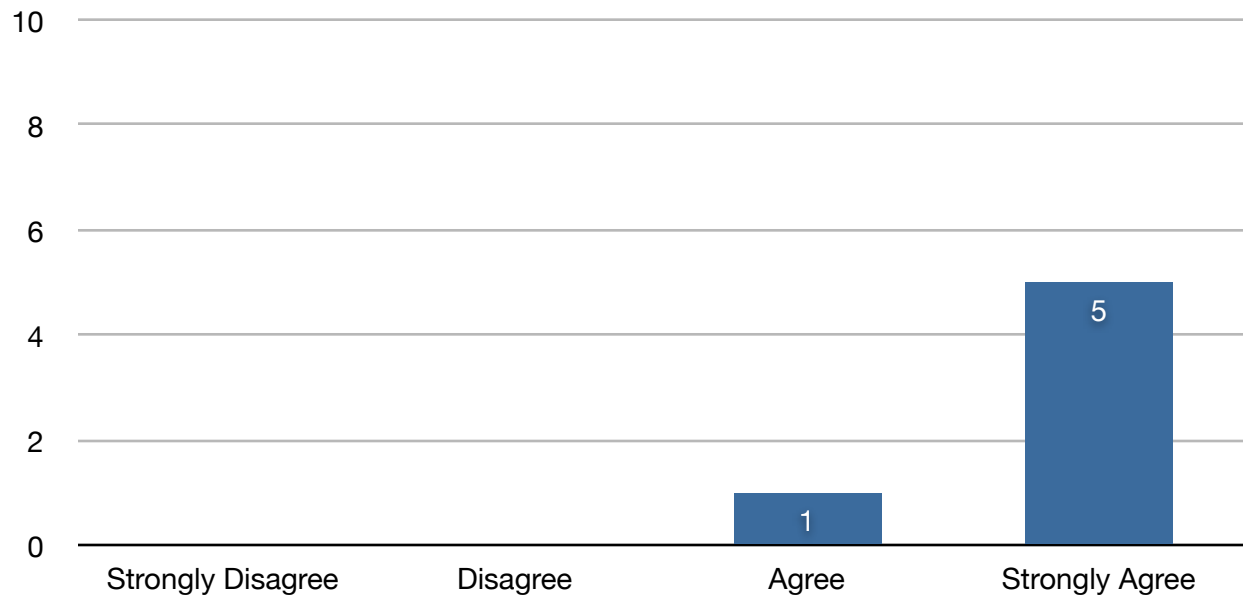
**Q19: I feel like students are getting the education they need to succeed in the 21st Century.**



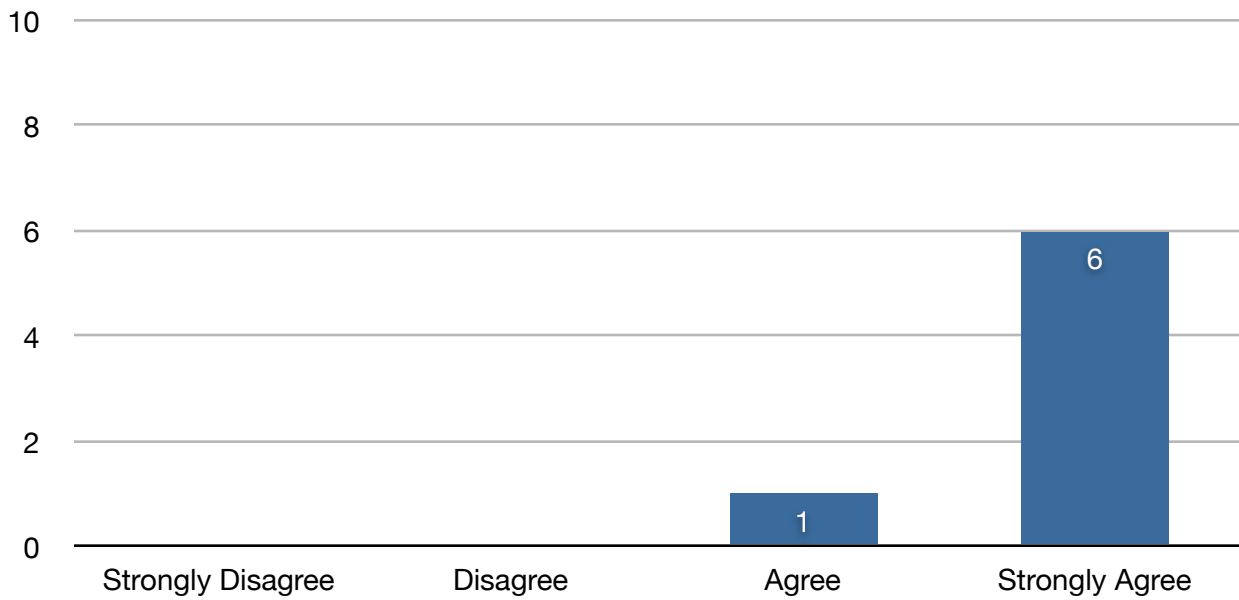
**Q20: All four school boards are aware of and support technology as a means to provide quality educational programs for 21st Century skills.**



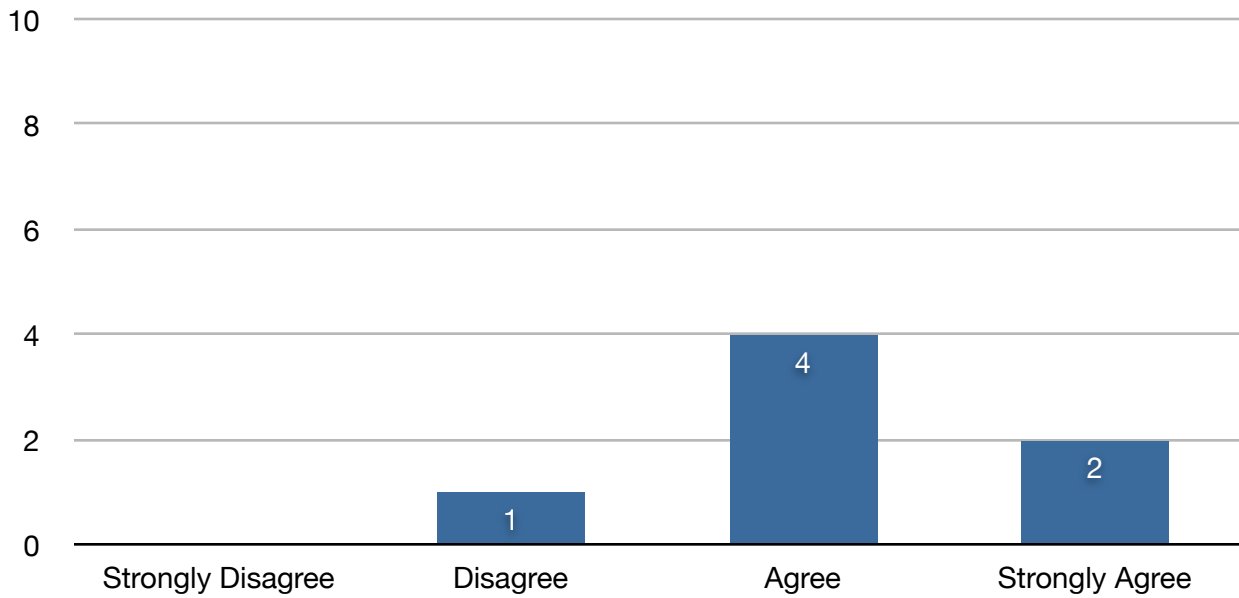
**Q21: It is important for teachers to use the mylearning online system, instant messaging, and video conferencing to send and receive course materials and communicate with distance education students on a confidential level.**
